Board Member Gregg Cooke reported on our first fundraiser. Hosts thanked and those that helped with the breakfast were recognized. \$900 raised – 50 attended. Another \$900 was donated previously. Our goal was to cover the cost of \$1500 for the Clean Water Clean Boat grant.

Board Member Valerie Laabs thanked Jim Sieber for bringing the CBCW program to Stormy Lake. We have spiny water flea in Stormy which we do not want to spread to other lakes. The CBCW grant provides interns May-August. Their main role is educational. We cannot wash boats due to our access. We will get a report at the end of the summer.

Official study on our lake quality by Cathy Higley will be available on a Zoom presentation on September 12.

Board Member Steve Fox reviewed the Courtesy Code. Dusk to dawn is a quiet time. Watch distance with power boat – 200 feet from piers, shore, and other boats. Please post the Code for any renters. Fireworks are a safety issue especially with projectiles.

Don Olson reported that the Secchi disc was visible at 17 feet of water last week. This clarity is an improvement from last year (14 feet). Don showed the Secchi Dish instrument he uses to measure the clarity. The best was 26 feet of clarity several years ago.

- Swimmer Itch-Linda Difino reported that it has been better.

New Business

- Dave Kamps reported on issues navigating a boat and trailer at the boat landing. He suggested asking the Town of Conover to consider posting No Parking signs in the area vehicles use as a turnaround and adding some marked parking places along the road.
- Wake Boats: please stay in the middle of the lake and watch your distance from shore.
- Hans Myklebust reported that skiers often get too close to rafts near their property. This seems to be getting worse.
- Berleen Carlton and Nancy Wurmle were recognized for their years of service on the Board with a plaque and card.

New Board was elected. Bruce Campbell recognized Debbie Benson-Maczko for her six years as President.
