Member Introduction: Those in attendance introduced themselves by including their location on the lake and the year they first came to Stormy Lake.

Eighty members were in attendance.

Minutes of the 2004 Annual Meeting: Reading of the minutes was dispensed with since copies had been mailed to the membership and were available at the meeting. There were no corrections.

Financial Report: Treasurer Berleen Carlton gave the following financial report.

The year began with a balance of \$ 2833.29 in checking and a CD.

Receipts totaled \$2370. (\$1595. in dues and \$775. dinner receipts) and disbursements amounted to a total of \$2134.63, leaving a current balance of \$3068.66 in checking. After earning interest, our CD is worth \$1064.49.

Dues continue to be collected for the 2005-06 year.

Fish Report Lois announced that 13,125 brown trout fingerlings were again planted in Stormy Lake this past March.

Lake Report Roger Rieckman reported that Stormy Lake is one of the clearest lakes in the area. Since we all believe that water quality is important, we need to keep phosphorus out of any fertilizer used on lawns to avoid phosphorus run-off in the lake.

At this time, the lake water temperature is in the 70° range 5' below the surface and about 48° at 60' of depth. In late September or early October of each year, the top-to-bottom temperature is about even at around 48-49°.

Transfer Station Canopy Don Hennessy reported that he and Wayne Anderson worked with the township to have a canopy built for shelter from the sun and rain at the transfer station. The Stormy Lake Association donated \$250. for this shelter, and 4 members contributed another \$100. Two shelters were built, and the transfer station manager (Don) appreciates them.

Jack Pine Trees The Jack Pine trees around our lake have been turning brown due to a Jack Pine bred worm that attacks the mature trees. These worms come about every 12 years and feed on new needle growth. There are three possible methods of dealing with the worms: 1. hand picking; 2. water blasting; and 3. lawn or garden insecticide. Jack Pine have a 50-60 year life.

#### Other Business

Jet Skiing: Cheryl Eskridge brought up the fact that many jet ski operators on our lake are not acting responsibly. Wisconsin state law regulates the use of Personal Water Craft, and the minimum safe distance from shore, rafts, piers, swimmers and other boats is set at 200 feet for PWC. This distance is given in our SLA 2003 directory (the current directory), under "Boating Regulations Summary (Wis. State Law)". For further information on the use of PWCs, refer to the Wisconsin Boating Regulations which come with vehicle registration cards and numbers.

Boat Landing: Vigilance is required at the boat landing this year. The township made some effort to improve the situation by removing the one concrete slab that buckled and was causing problems and by the addition of gravel at the end of the slabs where a deep hole existed. But boats that are being driven onto trailers, engines gunned, are blowing the gravel and rocks out again, and the situation is not good.
